KIWANIS HISTORY

Kiwanis International confirms our club is currently the 113th Kiwanis Club to have been formed in the world — out of "over 8,600 clubs world-wide with over 300,000 members." We are one of the first! We are one of the oldest! Things (and people too) become valuable simply because they have become old. So buck up guys:

Dear Mr. Evans:

Because of the seasonal workoad of the Member Services area (dues billings, particularly), I offered to answer your inquiry, and I hope what follows will help you.

Of the 122 clubs that preceded yours in organization date, these clubs are no longer in existence:

New York, N.Y. (the first one organized) - #8 Providence, R.I. - #43 Boston, Mass. - #51 Newark, N.J. - #76 (another Newark club was organized in 2000) Philadelphia, PA - #79 Paterson, N.J. - #81 Northampton, Mass. - #86 Binghamton, N.Y. - #94 New York, N.Y. (the second one organized) - #98 Jersey Shore, PA - #119

All others are still in existence.

With regard to when your club "came into existence," Kiwanis International considers the official organization date (the date on which a club elects its charter officers and directors, adopts bylaws, formalizes the club name, time and date of club meetings) to be a club's "official birthday." In your case, the official organization date is March 11, 1919; that's the one that counts. The actual charter presentation is considered to be considered to be a social event. This is why it is very often called a "charter party." Always, it takes place after the organization date. In the early days, sometimes as much as a year later. The date of August 18, 1918 has no local significance to your club, nor to any other, really. It is the date on which Kiwanis International was officially approved as a corporation under the laws of Illinois (where the International Office was then located). All club charters bore that seal with that date. Now, of course, we are incorporated in Indiana.
